A charm offensive to promote mediation, for the benefit of all mediators in the Swiss nation

GENEVACCORD ADR is organizing a bold venture in Geneva to benefit all those who support conflict mediation in Switzerland!

We are producing an educational stage play portraying a real mediation case: an ambiguous human triangle, full of twists and misunderstandings, with the characters acted by Stéphanie Leclef, Alain Carré and Aïssa Derrouaz. The mediator and lawyers will be professionals from the Republic and Canton of Geneva. The play will be interrupted by short educational sessions, led by Maître Virginie Martins de Nobrega, a lawyer and mediator from Paris, and Maître Patrick-Etienne Dimier, a lawyer and mediator from Geneva, both members of GENEVACCORD ADR.



In the final part, after the intermission, a prosecutor and a defense lawyer will debate conflict mediation. At the gala evening on Wednesday 22 October, 2014, Maître Marc Bonnant will give a speech commensurate with his reputation as a defense lawyer.

Taking place at the Les Salons theater *(photo)*, the event will serve to lift the veil on mediation, demystifying the process, showing how it works and throwing light on the features of this innovative method which are ill understood, while maintaining strict confidentiality about current mediation cases. This original project will be a unique opportunity to get right to the heart of this method for empowering people to resolve conflicts.

GENEVACCORD ADR is looking forward to sharing this experience with policy makers, the judiciary, judges and lawyers, notaries, business leaders, journalists, mediators, members of the various Swiss mediation organizations, and the general public.

Guy A. Bottequin elected vice president of Groupement Pro Médiation and a member of the steering committee of the Swiss national umbrella organization for mediation SDM-FSM!

The General Assembly of the Groupement Pro Médiation (GPM <u>www.mediations.ch</u>), at which the Steering Committee was elected, was held on 19 May, 2014.

Already a member of the GPM's Steering Committee, Guy A. Bottequin was then elected vice president. The committee is again chaired by the Honorary Professor and counsel lawyer, Christian-Nils Robert.

Guy A. Bottequin has also been elected a member of the Steering Committee of the Swiss Federation of Mediation Organizations (SDM-FSM www.infomediation.ch/cms) on 23 May, 2014, at the Assembly of Delegates. Why should I be out of mind


Because I am out of sight?
